PRESIDENT'S REPORT



Michael Cameron President

This season has been a landmark year for our club — defined by growth, resilience, and a remarkable depth of community spirit. From lifesaving operations to grassroots development, we've advanced the club's capability, broadened our membership base, and strengthened our position as a vital community organisation both on and off the beach.

Membership reached a historic high with 469 registered members by season's end, including a significant rise in active patrolling numbers. This growth enabled the creation of a sixth patrol team — notably, an all-female unit that demonstrates our commitment to inclusivity and evolving club culture. Our lifesavers collectively logged over 2,500 patrol hours, reflecting immense dedication and a strong operational presence along the coastline.

The season saw our club heavily involved in emergency operations, with multiple members deployed during Tropical Cyclone Alfred and the historic Taree flood events. Our response teams played key roles, with personnel mobilised swiftly in support of the broader Surf Life Saving NSW efforts. Our callout team maintained an impressive standard, highlighted by their rapid response to the rescue of two boys caught in dangerous surf conditions near sunset. From first alert to having the IRB and ATV on the beach took less than 10 minutes, a clear sign of our readiness and professionalism.

Our Nipper program continues to thrive, with over 90 kids on the beach supported by a growing team of water safety volunteers and age managers. Their energy and dedication shaped a vibrant learning environment each weekend. A standout moment was our joint day with Crowdy Head SLSC — a truly successful event showcasing cross-club engagement and collaboration. The camaraderie and fun shared that day were a reflection of everything our junior programs strive to build.

Our clubhouse remains a beacon for community connection. Sunday Sippers continued to grow, providing not only a strong income stream but also an atmosphere that welcomed new faces and retained old ones. The “Clubhouse Crew” works committee and “Bar Maids” have done an extraordinary job in making the venue warm, functional and inviting. We also saw a successful revamp of the flat, with renovations including new windows, flooring and paintwork — now producing regular income for the club and a presence outside of hours.

Throughout the season, members engaged in high-quality training and development programs. We welcomed 12 new qualified Bronze Medallion holders, 6 Surf Rescue Certificate graduates, 3 IRB Drivers, and 3 IRB Crew. Several members also completed advanced courses such as 4 Rescue Water Craft Operator certifications, 2 Silver Medallion Patrol Captain and Level 2 Incident Management — strengthening the club’s capability for deployment and response readiness.

Members also showcased their capability at competition within the branch, to Aussies and as far afield as the United Kingdom, where our club was represented in a multi-agency rescue event. The team won the in-water challenge — a testament to the high standards we nurture and the opportunities available through Surf Life Saving.

These skill-building efforts underscore our long-term investment in safety and sustainability.

Recognition was a major theme this year. At our annual Presentation Day, we celebrated some remarkable individuals: Amy Dyer was awarded Club Person of the Year, and Jane Lynch was elevated to Life Member, the highest honour within our club in acknowledgement of her tireless service. Other honourees included Joe Dunn and Kim Moses as Male and Female Club Members of the Year, Patrick Moses for Patrol Member of the Year, and Ken and Di Mulligan for their volunteer efforts. Andrew Somerville, Graham Moses and Jane Lynch were recognized with National Service Medals and many with Patrol Awards across 5, 10, 15 and 20 year brackets. The club also featured heavily in the Branch Awards, with accolades spanning coaching, administration, surf lifesaving, and rescue services.

On the infrastructure and funding front, the club secured a substantial \$48,266 grant under the Surf Club Facility Program, which has been put towards key safety upgrades including LED lighting, PA, handrails, board racks and water tanks. We continue to pursue further grants, with applications pending for Volunteer Support, Community Building Partnership, and success in obtaining \$70,000 through Midcoast Council's Section 94 Council funding. Meanwhile, ongoing discussions around our club lease with Midcoast Council have progressed slowly, though we've remained proactive and persistent.

As the season closes, the energy and heart within the club couldn't be stronger. I want to personally acknowledge every single member who contributed — whether on the sand, behind the scenes, or in leadership. Special thanks go to our Executive Committee: Amy Dyer, Kasey Brown, Nev Finch, Jay Clarke, Andy Snelgar, Graham Moses and Joe Dunn. Your leadership and drive have guided the club through a season full of achievement and momentum. Thank you for allowing me to be President of the club for the 2024/25 Season, it is both an honour and a privilege.

Looking forward, we'll continue working closely with Surf Life Saving NSW on the Club Capability Project, pursue the acquisition of a UAV (drone), and foster the next generation of surf lifesavers. We're not just protecting the beach — we're building something special.



 - Last season the Surf Boat was going to be sold due to no interest. However, the boat was prepared for use earlier in the season, with conversation of a team looking to start up. Sadly, this didn't eventuate.
 - Therefore, at the last meeting of this season, the decision was made to sell the boat to make room usable rescue equipment such as the Jet Ski.
 - As of this report the surf boat is no longer on TOBSLSC property.



NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

These financial statements cover Taree Old Bar Surf Life Saving Club Incorporated as an individual entity. Taree Old Bar Surf Life Saving Club Incorporated is an association incorporated in New South Wales under the Associations Incorporations (NSW) Act 2009. The Association is domiciled in Australia.

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards – Simplified Disclosures adopted by the Australian Accounting Standards Board (AASB) and the requirements of Division 60 of the Australian Charities and Not-for Profits Commission Act 2012 and the Charitable Fundraising Act 1991. The Association is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

Basis of preparation

The financial statements are presented in Australian dollars and have been prepared on an accruals basis and are based on historical costs. Cost is based on the fair values of the consideration given in exchange for assets.

The following is a summary of the material accounting policies adopted by the Association in the preparation of the financial statements.

The accounting policies have been consistently applied, unless otherwise stated.

The financial statements were approved by the Board of Management on 13th July 2025.

Estimates and judgments

The preparation of financial statements requires management to make judgments, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates. Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in any future periods affected.

Leases

Leases are capitalised, recognising a right to use asset and a lease liability.

The right to use asset is initially recognised at the present value of the lease payments that are unpaid at the date of recognition. Lease payments are discounted at the interest rate implicit in the lease.

The lease liability is initially recognised at the carrying amount of the right to use asset increased by the interest on the lease liability.

Right of use assets are depreciated on a straight-line basis over their estimated useful lives.

Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period.

Financial Instruments

Non derivative financial instruments

Non derivative financial instruments comprise investments in debt securities, trade and other receivables, cash and cash equivalents and trade and other payables.

Non derivative financial instruments are initially recognised at fair value. Subsequent to initial recognition non derivative financial instruments are measured at fair value.

Cash and cash equivalents

Cash and cash equivalents comprise cash on hand and at call deposits with banks or financial institutions. Bank overdrafts that are repayable on demand are included as a component of cash and cash equivalents for the purpose of the statement of cash flows.

Trade and other receivables

Trade and other receivables are stated at their amortised cost less impairment losses.

Investments

If the Association has the positive intent to hold debt securities to maturity, then they are measured at amortised cost using the effective interest rate method less any impairment losses.

Trade & other payables

Trade and other payables are stated at their cost.

Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation and impairment losses. Cost includes expenditures directly attributable to the acquisition of the asset. The costs of day to day servicing of property, plant and equipment are recognised in the profit and loss as incurred.

Gains and losses on disposal of an item of property, plant and equipment are determined by comparing the proceeds from disposal with the carrying amount of property, plant and equipment and are recognised net within other income or other expenses in the profit or loss.

Depreciation

The depreciable amount of all plant & equipment is depreciated on a straight line basis over their useful lives commencing from the time the asset is held ready for use. Land is not depreciated. Rates and methods are reviewed annually for appropriateness.

The depreciation rates used for each class of depreciable assets are:

Impairment

At each reporting date the Association reviews the carrying values of its financial assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the difference between the assets carrying amount and the estimated future cash flows discounted at the original effective interest rate is recognised through the profit and loss as an impairment loss.

The carrying value of the Association's non financial assets are also reviewed at each reporting date to determine if there is an indication of impairment. If an indication exists then the assets recoverable amount, being the higher of its value in use and its fair value less costs to sell, is estimated. An impairment loss is recognised in the profit and loss if the carrying amount exceeds the recoverable amount.

Employee benefits

Short-term benefits

Liabilities for employee benefits for wages, annual leave and sick leave arising from services rendered by employees to the reporting date represent present obligations. Employee benefits expected to be settled within one year have been measured at the amount expected to be paid when the liability is settled, plus related on-costs such as workers compensation and payroll tax (where applicable).

Long-term benefits

Other employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits. The discount rate is the yield at reporting date on AA credit rated or government bonds that have maturity dates approximating the Association's obligations.

Superannuation

Contributions are made by the Association to employee superannuation funds and are charged as expenses when incurred.

Inventories

Inventories are measured at the lower of cost and net realisable value.

Income Tax

The Association has been granted an exemption from Income tax under Section 50-45 of the Income Tax Assessment Act 1997. The exempt status of the Association applies indefinitely or until such time as a change in circumstances warrants a review of the exempt status. The Association is also an income tax exempt charity and public benevolent institution and is eligible for GST and FBT concessions.

Cash

For the purpose of the statement of cash flows, cash includes:

- cash on hand and at call deposits with banks or financial institutions, net of bank overdrafts; and
- investments in money market instruments with less than 14 days to maturity.

Comparative Figures

Where required Accounting Standards comparative figures have been adjusted to conform with changes in presentation for the current financial year.

Revenue

Revenue from the sale of goods is recognised on delivery of goods to customers. Revenue from the rendering of a service is recognised upon the delivery of the service to the customers.

Revenue from government subsidies is recognised in the period advised by the funding body for the delivery of service.

Revenue from membership subscriptions is recognized as received.

All revenue is stated net of the amount of goods and services tax (GST).

Goods and services tax

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). In these circumstances the GST is recognised as part of the cost of the acquisition of the asset or as part of an item of expense.

Receivables and payables are stated with the amount of the GST included.

The net amount of GST recoverable from, or payable to, the ATO is included as a current asset or liability in the Statement of Financial Position. Cashflows are included in the Statement of Cash Flows on a gross basis. The GST components of cashflows arising from investing and financing activities which are recoverable from, or payable to, the ATO are classified as operating cashflows.

Government Grants

An unconditional government grant is recognised in the profit or loss as other income when the grant is received.

Grants received to assist in the construction of non current assets is recognised on a percentage of completion basis of the construction in accordance with AASB1058.

Finance income

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

New Standards and Interpretations not yet adopted

The Board of Management considers that new standards and interpretations currently issued but not yet applicable will not have a significant impact on the Association's financial statements.

NOTE 16: FINANCIAL RISK MANAGEMENT

Credit Risk

Credit risk is the risk of financial loss to the Association if a customer fails to meet its obligations and arises principally from the Association's receivables from customers. The maximum exposure to credit risk, excluding the value of any collateral or other security, at reporting date to recognised financial assets is the carrying amount, net of any provisions for impairment of those assets, as disclosed in the Statement of Financial Position and the Notes to the Financial Statements.

Trade and other receivables

The Association's exposure is influenced mainly by the individual characteristics of each customer. Customers are Club members who pay annual subscriptions and people who hire and use the Clubs premises.

Investments

The Association limits its exposure to credit risk by investing in term deposits with recognised financial institutions.

Liquidity risk

Liquidity risk is the risk that the Association will not be able to meet its financial obligations as they fall due. To ensure it can meet its obligations the Association invests excess funds in a cash management account, term deposit and monitors daily expenditure.

Market risk

Market risk is the risk that changes in market conditions will affect the Association's income. The Association has exposure to market risk as it is reliant on the continued use of facilities and on memberships. Government initiatives can have a significant impact on this risk area and will continue to do so in future years.

Interest rate risk

Investments in held to maturity investments are not exposed to interest rate risk and they are invested at a fixed interest rate and short term receivables and payables are not exposed to interest rate risk as they are non interest bearing.

Fair value

Unless otherwise stated carrying amounts disclosed on the Statement of Financial Position are the fair value of the financial assets and liabilities.

Qualification

The financial report for the year ended 30 April 2024 was audited by PDD Advisory Group Port Macquarie. This audit was qualified in regards to whether revenue from cash, donations and fundraising activities was complete. We have included the comparative information based on those financial statements but as we were not the auditors for the year ended 30 April 2024 we are unable to express an opinion on the 30 April 2024 comparative information included in this report.

Qualified Conclusion

Based on our review, which is not an audit, with the exception of the matter noted in the qualification paragraph above, we have not become aware of any matter that makes us believe that the financial report of the Taree Old Bar Surf Life Saving Club Incorporated does not satisfy the requirements of Division 60 of the Australian Charities and Not-for profits Commission Act 2012 including:

- a) giving a true and fair view of the Associations financial position as at 30 April 2025 and its performance for the year ended on that date; and
- b) complying with Australian Accounting Standards – Simplified Disclosures and Australian Charities and Not-for profits Commission Regulations 2022.
